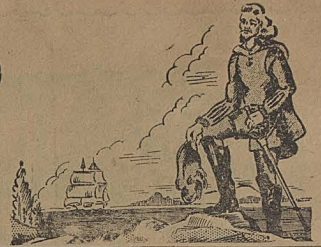

NEW TRUCK FOR LA SALLE UTILITIES

The La Salle Public Utilities Commission are now sporting a new 1 1/2 ton maintenance line truck, which is a Smith Brothers truck with a Chevrolet chassis.

The truck arrived on Tuesday, August 25th. They will also continue to use the 1/2 ton truck, owned by Mr. Clifford Ionson, Supt. of the La Salle Public Utilities Commission.

The Utilities found it necessary to purchase a new truck for handling heavy equipment, such as poles and transformers. The new truck is equipped with a winch and derrick.

Sandwich West Water Supply Low at Times

Inadequate mains in Sandwich West Township, which gets its water from the plentiful Windsor Utilities Commission water division, are the cause of their recent water shortage.

The Sandwich West Council, meeting in emergency session Sunday, August 30, voted down a proposal by Maynard Totten, chairman of the utilities commission, that restrictions on lawn watering and car washing be imposed. However, by Wednesday, September 2nd the council found it necessary to impose these restrictions.

LA SALLE COUNCIL MEETS

The regular meeting of the Tuesday evening, September 1st. Mayor Herbert Runstedler, councillors Ed Lovell, Leon Martin, Gordon Reume, Jack Trotter, and the assistant town clerk, Ted Seewald, were in attendance.

The new pumper for the fire La Salle Council was held department will not be ordered until the 33 acres of land near the golf course is sold, as the proceeds from this sale are required for the purchase of the new pumper. An offer to purchase this land for \$3,300 was received from Dr. A. Jung. Dr. Jung is to be advised that a settlement must be made within ten days, otherwise the council will sell to the next highest bidder.

A representative of C. E. Hickey and Sons Limited discussed the many special features of their pumper. The council will purchase the pumper from one of the following: Bickle-Seagrave Limited, La France Fire Engine and Foamite Ltd., or the C. E. Hickey and Sons Limited.

Mr. Henry Seewald, plumber, suggested that a bylaw be passed whereby all plumbing would have to be approved by a plumbing inspector. This would benefit the home owner, and protect the plumber. Mr. J. Wells is to write the Department of Health for the provincial regulations plumbing code. This will be discussed further at the next meeting.

It was approved by the council that Mrs. Marie Le Claire be granted a permit to move her house a distance of approximately thirty feet on Reume Road. Mrs. Le Claire plans to make an addition to the house immediately in order

to conform with the required number of square feet.

Eleven complaints were received from residents living behind the Sunnyside Hotel, regarding the foul odour caused by the stagnant water. As long as these residents would agree to absorb all expenses involved, the council would be glad to assist in any way.

Application to purchase lots Nos. 24, 25, 26, 27, Plan No. 848, on Delaware avenue, was made by Paul Pajot. These may be purchased at \$150 per lot. Ernest Meloche made application to purchase lots Nos. 32, 33, 34, Plan No. 844, on Reume road, at \$125 per lot. Application to purchase lots Nos. 337, 342, 344, Plan No. 777, on Maple street, and lots Nos. 174, 176, 184, Plan 854, was made by Vital Benoit. These may be purchased for \$100 per lot. The La Salle Public Utilities' Commission made application to purchase lot No. 28, Plan No. 1174. The council will hold this application.

The next regular council meeting will take place on Monday, September 21st.

PRECAUTION

AGAINST FIRES

The town of LaSalle is now facing its third month without the protection of its local fire department. The LaSalle pumper is unserviceable.

Our fire department was called to extinguish a grass fire last week on Michigan and Maple, an area where several new homes are under construction. The department was fortunate enough to extinguish this fire with brooms and shovels as their only aid.

Last Saturday afternoon, a second fire took place. This time at the home of Mr. Steve Zojac on Matchet road, near the golf course. The Zojac family was in Windsor when a neighbour, Mr. Homer Lepine, observed smoke and flames in a shed 20 feet back of the garage which was only 9 feet from the Zojac home.

Mr. Lepine called the LaSalle Fire Department, and then attaching a garden hose, commenced to extinguish the fire which had by this time progressed to the garage. Shortly, the LaSalle Fire Dept. arrived with only two 2½ gal. extinguishers with which to combat the fire. The shed was completely destroyed, while the garage was saved.

It is obvious that had the garage burned, the home would have been in a disastrous position. The nearest hydrant was three-quarters of a mile from the Zojac home, so without a pump and booster tank, very little could have been done to save the house, had it caught on fire.

The need of a new pumper is urgent. Your home could possibly be destroyed by fire before the Windsor Fire Department could arrive. You are cautioned to use every precaution to guard against fires.

The delay in purchasing the new pumper is due to the lack of funds. In order to raise the required amount, the town plans to sell thirty-three acres of land and to borrow the remainder of the money from the bank. The sale of this land is still not completed. Would it not be possible to borrow the entire amount from the bank, purchase the needed pumper, and repay the bank when this land is sold?

And will the individual's fire insurance premium be increased if this delay continues?

Let's hope our new pumper is ordered within the next few days as delivery will be thirty working days from the order date.

Once again, citizens, you are cautioned to take every precaution to avoid fires during this critical waiting period.

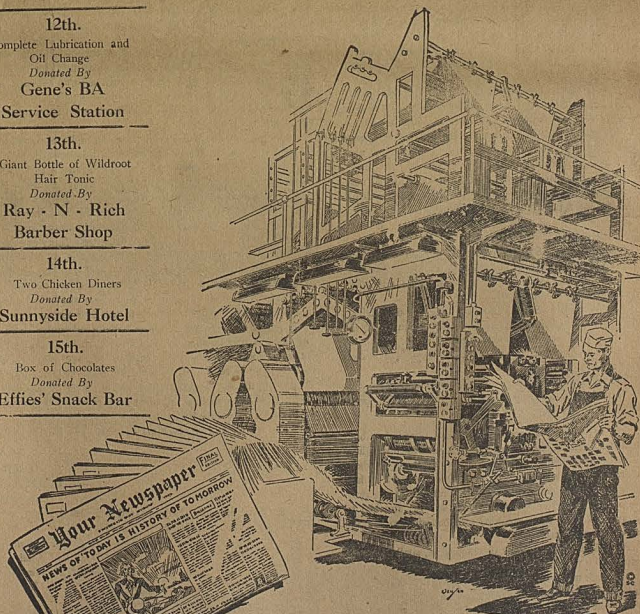

**Roman Catholic School Section Number 4.
The Corporation of the Township of
Sandwich West, BY-LAW NO. 5**

A by-law to authorize the borrowing of Twelve thousand dollars (\$12,000.00) by the issue of debentures upon the credit of the School Board for the payment of certain capital expenditures.

WHEREAS it is expedient to borrow the sum of Twelve thousand dollars (\$12,000.00) upon the credit of the School Board to issue debentures therefor bearing interest payable annually at the rates shown in the third column of Schedule "A" attached to this by-law and to provide for the discount and expenses incidental to the negotiation and sale of such debentures;

AND WHEREAS it is expedient to make the principal of the said debt repayable in annual instalments during the period of four years next after the date of issue of such debentures of such amounts respectively that, with the interest in respect of the debt, the aggregate amount payable for principal and interest in each year, shall be as nearly as possible the same, subject to the provision that each instalment of principal may be for an even one hundred dollars (\$100.00) or multiple thereof, and that notwithstanding anything herein contained, the annual instalments of principal and interest may differ in amount sufficiently to admit thereof;

AND WHEREAS the amount of the whole rateable property of the School Section, according to the last revised assessment roll thereof is One million two hundred and fifty-four thousand dollars (\$1,254,000.00).

AND WHEREAS the amount of the existing debenture debt of the School Section, exclusive of local improvement debts secured by special rates or assessments is nil and no part of the principal or interest of such debt is in arrear;

THEREFORE the Board of Trustees of Roman Catholic School Section Number 4 in the Township of Sandwich West ENACTS AS FOLLOWS;

1. For the purpose aforesaid the School Board shall borrow upon the credit of the School Board a sum not exceeding Twelve thousand Dollars (\$12,000.00) and shall issue debentures therefor in sums of not less than One Hundred dollars (\$100.00) each. Each debenture shall bear interest at the rates set out for the respective years in Schedule "A" attached to this by-law and shall have coupons attached thereto for the payment of the said interest.

2. All debentures shall bear the same date, shall be issued at one time and within one year after the day on which this by-law is passed, may bear any date within such year and shall be made payable in annual instalments during the period of four years next after the date of issue thereof, and the respective amounts of principal and interest payable in each of such years shall be the amounts so designated in Schedule "A" hereto annexed.

3. The debentures shall be payable as to both principal and interest in lawful money of Canada and may be payable at such place or places in Canada as shall be designated thereon.

4. The said debentures shall be sealed with the seal of the School Board and signed by the Chairman of the School Board or by some other person authorized by by-law to sign the same,

and by the Treasurer. The said interest coupons shall be signed by the Treasurer and his signature thereon may be written, stamped, lithographed or engraved.

5. Commencing in the year 1954 and thereafter in each year in which an instalment or principal of the said debt and interest become due, the School Board shall levy and raise the specific sum shown for the respective year in the fourth column of the said Schedule. Such sum shall be levied and raised by a special rate sufficient therefor, over and above all other rates, upon all the rateable property in the School Section assessed to Separate School Supporters.

6. The said debentures may contain a clause providing for the registration thereof pursuant to Section 335 of the Municipal Act.

7. Pending the sale of the said debentures, the Chairman of the School Board and the Treasurer may raise for the purpose aforesaid by way of loan on such debentures, any sum or sums of money not exceeding in the full the amount authorized to be borrowed and may hypothecate such debentures for such loan.

8. The School Board shall have the right, at its option, to redeem the said debentures either in whole or in part on any date prior to maturity at the places where and in the monies in which the said debentures are expressed to be payable, upon payment of the principal amount thereof together with interest accrued to the date of redemption and upon giving previous notice of said intention to redeem by advertising once in the Ontario Gazette and once in a daily newspaper of general provincial circulation, published in the City of Windsor, and once in a local newspaper, if any, such notice to be advertised as aforesaid at least thirty days before the date fixed for redemption. Notice of intention so to redeem shall also be sent by post at least thirty days prior to the date set for redemption of each person in whose name a debenture so to be redeemed is registered, at the address shown in the Debenture Registry Book. Where only a portion of the debentures of this issue is so to be redeemed, such portion shall comprise only the debentures that have the latest maturity dates and no debenture of this issue shall be called for such redemption in priority to any such debenture that has a later maturity date.
